REACTIVATION OF PROJECT MONITORING COMMITTEE

WHEREAS, Executive Order No. 376 s. 1989 Establishing the regional project monitoring and evaluation system (RPMES) and for other purposes to facilitate project implementation and devolve facilitation, problem solving, monitoring and evaluation of foreign, national and locally funded projects to the sub-national levels.

WHEREAS, as provided in the aforementioned EOs, Project Monitoring Committees (PMCs) originally established as the monitoring arm of the Local Development Councils under Memorandum Order No. 175 dated May 23, 1988 were tapped to operationalize the RPMES at the sub regional level.

NOW THEREFORE, **I, CONCEPCION A. ZARATE**, Municipal Mayor of Pura, Tarlac under the power and authority vested in me by law do hereby ordain and decree that;

Section 1 There is hereby reactivated Project Monitoring Committee to be composed of the following:

Section 2 The Project Monitoring Committee shall monitor to ensure that all infrastructure projects and the purchase of supplies, equipment's and other materials are implemented as to their specifications, there is that imperative need to monitor implementation thereof in order to prevent or discourage unscrupulous persons from taking advantage of the project preparation as well as implementation.

Likewise, the Committee will also monitor the projects funded by the Assistance to Depressed Municipalities (ADM) and Bottom-Up Budgeting, which is being undertaken by the Poverty Reduction Action Team (PRAT). The PMCs shall have a parallel monitoring of ADM and Bottom-up Budgeting projects with that of PRAT.

Section 3 This order shall take effect immediately.
