EXECUTIVE ORDER NO. 006 S. 2017

AN ORDER RE-ORGANIZING THE MASA MASID GROUP IN THE MUNICIPALITY OF PURA, TARLAC

WHEREAS, Article II, Section 23 of the 1987 Philippine Constitution states that, "The State shall encourage non-governmental, community-based, or sectoral organization to promote the welfare of the nation;

WHEREAS, section 3 (1) of Republic Act No. 7160, also known as the Local Government Code of 1991, states that, "The participation of the private sector in local governance, particularly in the delivery of basic services, shall be encouraged to ensure the viability of local autonomy as an alternative strategy for sustainable development;"

WHEREAS, section 35 of the Code also provides that LGUs may enter into joint ventures and such other cooperative arrangements with people's and non-governmental organizations to engage in the delivery of certain basic services and capacity building;

WHEREAS, DILG Memorandum Circular No. 2016-116 as amended by Memorandum Circular 2017-112 providing for the guidelines in the implementation of the Mamamayang Ayaw sa Anomalya, Mamamayang Ayaw sa Illegal na Droga (MASA MASID) specifies that the MASA MASID program is a community-based initiative to engaged volunteers in the fight against criminality, corruption, illegal drugs, violent extremism, and other threats to peace and order;

WHEREAS, multi-sectoral and mass- based approach shall be adopted by reorganizing MASA MASID Groups (Steering Committee, Technical Working Groups, Masa Masid Teams & Masa Masid Volunteers) to bring together the government and the private sector to achieve peaceful, orderly, and safe communities;

WHEREAS, there is a need to reorganize the MASA MASID Groups in the *Municipality of Pura* in accordance with the composition provided in DILG MC 2017-112;

NOW THEREFORE, I CONCEPCION A. ZARATE, by the powers vested in me by laws as Municipal Mayor of Pura in the Province of Tarlac hereby orders the following:

SECTION 1: Creation of the MASA MASID Steering Committee in the Municipality of Pura, Tarlac. Pura's Masa Masid Steering Committee is hereby organized to be constituted as follows:

Section 2. Responsibilities of Steering Committee. The Steering Committee shall have the following responsibilities:

- Oversee the implementation of the Project;

- Mobilize the support of the LGU's and key stakeholders; and
- Monitor the implementation of the Project

Section 3. Creation of the MASA MASID Technical Working Group. The Municipality's TWG is hereby organized and shall be composed of the following:

Section 4. Responsibilities of Technical Working Group. The following shall form part of the responsibilities of the MASA MASID TWG:

- Establish the MASA MASID modes of reporting in the C/M level and put place an effective reporting mechanism to ensure that reports are properly acted upon;
- Consolidate reports coursed through the modes of reporting, validate submitted reports and refer to concerned agencies if needed;
- Organize and mobilize the MMT's;
- Organize and mobilize MASA MASID Volunteers (MMV);
- Ensure effective implementation of MASA MASID Activities; and
- Provide effective and regular monitoring and evaluation mechanism.

Section 5: Meetings. The Technical Working Group shall convene at least twice a month on a specified date, time, and place determined by the chairperson.

Section 6. Repealing Clause. All issuances, orders, and memoranda issued inconsistent herewith are hereby nullified and/or repealed.

Section 7. Effectivity. This Executive Order shall take effect immediately.
