**CREATION OF THE LGU PERFORMANCE CHALLENGE FUND (PCF) PROJECT IMPLEMENTING TEAM OF LGU-PURA, TARLAC**

**WHEREAS**, pursuant to the provision of the Local Government Code of 1991 (RA7160), the Local Government has jurisdiction over all programs and projects designated for the promotion and general welfare of its constituents;

**WHEREAS**, the Performance Challenge Fund (PCF) for Local Government Units is a flagship program of the DILG that serves as a facility that will help stimulate LGUs that put premium on transparency and accountability to enable them to avail themselves of financial support to jumpstart and sustain local socio-economic development initiatives supportive of national government goals and priorities. It is an incentive fund to eligible LGUs to support the implementation of high-impact capital investment projects in the Annual Investment Program (AIP);

**WHEREAS**, the Performance Challenge Fund (PCF) is an incentive to LGU's conferred with the Seal of Good Local Governance (SGLG) administered by the Department of the Interior and Local Government (DILG);

**NOW WHEREFORE, I, FREDDIE DIAMSAY DOMINGO**, Municipal Mayor of Pura, Tarlac, and by the authority vested in me by law do hereby order –

Article I. **CREATION**. There shall be created a PCF Project Implementing Team for the Municipality of Pura, Tarlac.

Article II. **COMPOSITION**. The PCF Project Implementing Team of Pura, Tarlac shall be composed of the following members:

Article III. **OBJECTIVE**. To enable and support Local Authorities to achieve sustainability in their services in rural and urban governance and assist in the attainment of the Sustainable Development Goals and AMBISYON 2040. The local authorities shall be facilitated to take informed and well-planned decisions.

**SECTION 6. EFFECTIVITY**

This order takes effect immediately upon signing thereof and supersedes all other issuances inconsistent therewith.
