AN EXECUTIVE ORDER BANNING THE ENTRY AND EXIT OF LIVE PIGS, PORK AND PORK RELATED PRODUCTS IN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF PURA, TARLAC

WHEREAS, African Swine Fever continues to spread in many countries and has now entered the country causing massive economic losses to swine farmers and social dislocation;

WHEREAS, that there is an imminent threat of African Swine Fever that may spread and reach the municipality in such proportions that would require urgent, immediate and integrated action and response.

WHEREAS, the Local government Unit of Pura, Tarlac, to effectively accomplish and carry out the power prescribed under the General Welfare Clause of the Local Government Code of 1992 as provided for in Section 16 thereof, may prescribe orders affecting health, morals and peace and good order or safety and the general welfare of the people;

WHEREAS, in order to protect the public as well as the swine industry in the Municipality of Pura, Tarlac, it is imperative to abate the spread of ASF in any form.

NOW, THEREFORE, I FREDDIE DIAMSAY DOMINGO, Mayor of the Municipality of Pura, Tarlac, by virtue of the powers vested in me by law, do hereby order the following:

Section 1. Conduct of Check point in all point of entries in the Municipality of Pura, Tarlac.

The Municipal Agriculture Office, Punong Barangays and Sangguniang Barangay Members, Barangay Tanods and the Philippine National Police are hereby ordered to conduct checkpoints in coordination with the barangays concerned and the Philippine National Police in all point of entries and prevent the entry and exit of live pigs, pork and pork related products in the municipality.

Section 2. Prohibition of swill or left over foods to be fed to hogs.

The Sanitary Inspector and the Designated Market Supervisor is directed to inform all carinderia operators and other food establishments and food waste collectors to ensure the proper disposal of table left-overs or food wastes or swill. In no case should the food waste be distributed to hog raisers.

Section 3. Strict Implementation of Sanitary and Health Regulations in the Slaughterhouse and in the Public market.

Livestock suppliers are strictly prohibited to buy or source out live pigs, pork and pork related products outside of the territorial jurisdiction of Pura, tarlac. Livestock, particularly live pigs, to be transported to the slaughterhouse shall be accompanied by a certification issued by the Punong Barangay that the said hogs are procured in their respective barangay. The Officer in Charge of the

prohibited from selling pork meat and pork processed meat that are illegally slaughtered, undocumented or sourced out from illegal markets.

Section 6. EFFECTIVITY. This order shall take effect immediately and shall remain in force until expressly revoked.
