## **EXECUTIVE ORDER NO. 2020-12**

Series of 2020

### **AN ORDER PRESCRIBING SUPPLEMENTARY GUIDELINES RELATIVE TO THE IMPLEMENTATION OF ENHANCED COMMUNITY QUARANTINE WITHIN THE TERRITORIAL JURISDICTION OF PURA**

**SECTION 1. DECLARING THE MUNICIPALITY OF PURA UNDER THE STATE OF ENHANCED COMMUNITY QUARANTINE.** For the purposes stated in the preceding paragraph, the Municipality of Pura is to observe an enhanced community quarantine; the following rules shall be in force:

- a. Restriction on non-essential entry of people in the municipality;
- b. All residents are advised to remain in their homes at all times, except:
  - i. Health workers;
  - ii. Authorized government officials;
  - iii. Those travelling for medical or humanitarian reasons;
  - iv. Persons providing basic services and public utilities.
- c. Restriction on non-essential exit of people in the municipality, except:
  - i. Health workers;
  - ii. Authorized government officials;
  - iii. Those travelling for medical or humanitarian reasons;
  - iv. Persons providing basic services and public utilities.
- d. Movements of all residents and persons sojourning within the municipality shall be strictly restricted to their respective residences;





- e. All gathering of whatever kind shall be strictly prohibited while this order is in effect;
- f. Government offices shall continue to serve the public, but shall operate in accordance with Civil service Memorandum No. 6, Series of 2020;
- g. Suspension of classes in all levels for public and private schools and other learning institutions;

**SECTION 2. CURFEW.** In addition, a curfew for all persons in the municipality shall be implemented in the hours of 8:00 o'clock in the evening to 5:00 o'clock of the following morning until this order is lifted. The following person, however, shall be exempt from the curfew:

- a. Health workers;
- b. Members of Barangay Health Emergency Response Teams (BHERTs);
- c. Authorized government officials;
- d. Persons providing basic goods and services;
- e. Persons delivering food and medicines;
- f. Other persons authorized by the Inter-Agency Task Force.

**SECTION 3. TRANSPORTATION.** In connection, public transportation shall be suspended for the time being;

**SECTION 4. SELF-QUARANTINE.** All individuals with history of international travel and those coming from other provinces, shall inform the concerned barangay of their arrival and shall voluntarily subject themselves into a fourteen (14) day home quarantine period. BHERTs shall be vigilant in performing their functions. Non-cooperation shall be penalized under Republic Act 9271, otherwise known as the "Quarantine Act of 2004";

**SECTION 5. SET-UP OF CHECKPOINTS ON MAJOR ENTRY POINTS TO THE MUNICIPALITY OF PURA.** The Philippine National Police-Pura MPS shall maintain checkpoint stations on all entry points to Pura until this order is lifted.



**SECTION 6. BUSINESS ESTABLISHMENTS AND PRICE OF COMMODITIES.** All business establishments are ordered to faithfully comply with the suggested retail price of basic commodities and medicines. Non-compliance shall be a ground for revocation of business permit without prejudice to filing of proper charges prescribed under existing laws;

**SECTION 7. IMPLEMENTATION.** The Expanded Inter-agency Task Force created by virtues of EO No. 11, Series of 2020, the PNP-PURA MPS, BHERTs, BPATs, MDRRM, BDRRM and the Rural Health Unit of Pura shall ensure the enforcement of the provisions of this Executive Order;


**SECTION 8. SUPPLEMENTARY APPLICATION.** All other issuances of the DILG and other National Government Agencies shall have supplementary application to this Executive Order;

**SECTION 9. SEPARABILITY CLAUSE.** Should any of this Executive Order be declared invalid for any reason, parts that are not affected shall remain valid;

**SECTION 10. REPEALING CLAUSE.** All other issuance inconsistent herewith are deemed modified accordingly;

**SECTION 11. EFFECTIVITY.** This Executive Order shall be effective immediately.
