



EXECUTIVE ORDER NO. 2020-14
Series of 2020

**AN ORDER DECLARING TEMPORARY LIQUOR BAN
WITHIN THE TERRITORIAL JURISDICTION OF THE
MUNICIPALITY OF PURA FROM MARCH 18, 2020 UNTIL
APRIL 14, 2020**

By the power vested in me by law, I, **FREDDIE D. DOMINGO**,
Municipal Mayor of Pura, Tarlac, hereby issue the foregoing
Executive Order:

SECTION 1. DEFINITIONS. For purposes of this order, the
following shall mean:

ALCOHOLIC BEVERAGE – shall include beer, liquor or alcoholic
beverages, whether distilled or fermented, such as but not limited to
gin, brandy, whisky, beer or other locally fermented wines such as
tuba, basi and the like;

SECTION 2. PROHIBITED ACTS.





- a. The selling, delivering and/or serving of beer, liquor, or
alcoholic beverages of any kind by supermarkets, groceries,
convenience stores, sari-sari store or similar establishment, or
by a restaurant, panciteria, hotel or bar, whether licensed or
not, is hereby **ABSOLUTELY PROHIBITED** while the
municipality is under Enhanced Community Quarantine;
- b. Drinking of alcoholic beverages of any kind whether in a private
or public place, is likewise **ABSOLUTELY PROHIBITED**
while the municipality is under Enhanced Community
Quarantine;

SECTION 3. IMPLEMENTATION. The Philippine National Police-
Pura MPS together with the Inter-agency Task Force (COVID-19),
including members of Barangay Council and respective BPATs is
hereby authorized to implement this order.

SECTION 4. PENALTY. Any person who shall violate the provisions of this order shall be penalized under existing laws.

SECTION 5. SUPPLETORY APPLICATION. All other issuances of the DILG and other National Government Agencies shall have suppletory application to this Executive Order;

SECTION 6. SEPARABILITY CLAUSE. Should any of this Executive Order be declared invalid for any reason, parts that are not affected shall remain valid;

SECTION 7. REPEALING CLAUSE. All other issuance inconsistent herewith are deemed modified accordingly;

SECTION 8. EFFECTIVITY. This Executive Order shall be effective immediately.
