



EXECUTIVE ORDER NO. 19
Series of 2020

**AN ORDER DECLARING A GENERAL COMMUNITY QUARANTINE IN
THE MUNICIPALITY OF PURA, TARLAC.**

WHEREAS, it is the policy of the State to protect and promote the right to health of the people and instill health consciousness among them.

WHEREAS, the Local Government Code of 1991 state that municipalities President Duterte Issued Presidential Proclamation 922 to put the country In a State of Public Health Emergency in relation to National Security;

WHEREAS, the Municipality of Pura has imposed a State of Enhanced Community Quarantine through EXECUTIVE ORDER NO. 13, Series of 2020 on March 18, 2020;

WHEREAS, The Inter-Agency Task Force for the Management of Emerging Diseases (IATF-EID), adopts a policy of mandatory wearing of face masks by all residents of areas placed under ECQ;

WHEREAS, the Provincial Government of Tarlac on April 02, 2020 has issued Executive Order No. 11, series of 2020, requiring the mandatory use of mask in public places in the Province of Tarlac;

NOW, THEREFORE, I, FREDDIE DIAMSAY DOMINGO, Municipal Mayor of Pura, Ttarlac by virtue of the power vested in me by the law, do hereby order:

Section 1. MANDATORY USE OF FACE MASKS IN PUBLIC PLACES. All persons who are within the territorial jurisdiction of the Municipality of PURA, Tarlac are hereby MANDATED to use facemasks while outside of their respective residences, offices, and all other public places. The face mask must be sufficiently cover ones' nose and mouth and must be worn at all times.

Section 2. FACE MASKS ALLOWED. Face masks include earloop masks, indigenous, reusable or do-it yourself masks, face shields, handkerchiefs, or such other protective equipment that can effectively lessen the transmission of COVID-19.

Section 3. PENALTIES. Persons found in violation of this Order may be arrested and charged with the following, without prejudice to filing of other cases as may be enshrined in other issuances by superior government agencies.

1st Offense- Reprimand



2nd Offense- One Thousand Pesos (P 1, 000.00)

3rd Offense- Two Thousand Five Pesos (P 2, 500.00)

Section 5. REPEALING CLAUSE. All other issuance inconsistent herewith are deemed modified accordingly;

Section 6. EFFECTIVITY. This Executive Order shall be effective immediately.
