



EXECUTIVE ORDER NO. 2020-19a

**AN ORDER ESTABLISHING THE MUNICIPAL CONTACT TRACING TEAM (MCCT)
FOR COVID-19**

WHEREAS, Article II, Section 5 of the 1987 Constitution, declares that the state shall protect and promote the right to health of the people among others;

WHEREAS with the increasing cases of COVID-19, DILG Memorandum Circular No. 2020-062 was issued providing suppletory guidelines for Local Government Units (LGUs) in the implementation of the enhanced community quarantine;

WHEREAS, LGUs are enjoined to intensify implementation of COVID-19 related programs, projects and activities (PPAs) by the national government;

WHEREAS, Republic Act No. 11469, or the “Bayanihan to Heal as One Act”, has declared the urgent need to:

- (a) Mitigate, if not contain, the transmission of COVID-19;
- (b) Undertake measures that will prevent the overburdening of the healthcare system;
- (c) Immediately and amply provide healthcare including medical tests and treatments, to COVID-19 patients, persons under investigation (PUIs), or persons under Monitoring (PUMs);
- (d) Ensure that there is sufficient, adequate and readily available funding to undertake the foregoing;
- (e) Partner with the private sector and other stakeholders to deliver these measures and programs quickly and efficiently; and (h) promote and protect the collective interests of all Filipinos in these challenging times;

WHEREAS, DILG Memorandum No. 2020-073 dated April 13, 2020 was issued mandating LGUs to organize Contact Tracing Team (CTT) primarily to conduct contact tracing for all Persons Under Monitoring (PUMs), Persons Under Investigation (PUIs) and confirmed COVID-19 patients:

NOW, THEREFORE, I, FREDDIE D. DOMINGO, Municipal Mayor of Pura, Tarlac, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. Creation of Municipal Contact Tracing Team (MCTT) with the following composition:

SECTION 2. Duties and Functions. The MCTT shall have the following functions

1. Spearhead the implementation of DILG MC No. 2020-073
2. Conduct contact tracing to all persons with known exposure to a COVID-19 patient
3. Monitor the status of Person Under Investigation (PUI) and Person Under Monitoring (PUM)
4. Provide daily report to the COVID-19 Provincial & Regional Task Forces and so with other offices/agencies if necessary.
5. Perform such other functions as provided by higher authorities or by law.

SECTION 8. EFFECTIVITY. This Executive Order shall take effect immediately after signing hereof and shall remain in force unless sooner revoked, superseded or modified by subsequent Executive Order and other issuances.
