



EXECUTIVE ORDER NO. 20

**ORGANIZING THE COVID-19 CONTACT TRACING TEAM (CTT) IN THE
MUNICIPALITY OF PURA, TARLAC**

WHEREAS, the Republic Act No. 11469 or the *Bayanihan to Heal as One Act*, has placed the country in a State of National Emergency, and has declared the urgent need to; (a) mitigate, if not contain the transmission of COVID-19; (b) undertake measures that will prevent the overburdening of the healthcare system (c) immediately and amply provide healthcare, including medical tests and treatments, to COVID-19 patients, persons under investigation (PUIs), or persons under monitoring (PUMs); (d) ensure that there is sufficient, adequate and readily available funding to undertake the foregoing; (e) partner with the private sector and other stakeholders to deliver these measures and programs quickly and efficiently; and (h) promote and protect the collective interest of all Filipinos in these challenging times;

WHEREAS, the DOH Department Memorandum 2020-0151 issued on March 31, 2020 and DILG MC 2020-073 issued the Interim Guidelines on Expanded Testing for COVID-19, which is also directly issued to the Chief of the Philippine National Police, the Chief of the Bureau of Fire Protection all Local Government Units to fully assist and cooperate with the DOH in the conduct of the expanded testing for COVID-19;

NOW, THEREFORE, I, FREDDIE D. DOMINGO, MUNICIPAL MAYOR, Pura, Tarlac by virtue of the power vested in me by the law, do hereby order:

Section 1. ORGANIZATION AND COMPOSITION OF CONTACT TRACING TEAM (CTT)

There shall be an organized Contact Tracing Team and shall be composed of the following:

Chairperson	:	FREDDIE D. DOMINGO, Municipal Mayor
Lead	:	PCPT ARNEDO C PINEDA Municipal Chief of Police
Co-Lead	:	DR. LIBERTY DOMINGO, Municipal Health Officer DR. ROEDEL DIZON, Municipal Health Officer
Members	:	Staff from PNP Municipal Police Station Staff from Municipal Health Office Staff from Bureau of Fire Protection ARCH. ARSENIO SABADO III, MDRRMO Municipal/Barangay Health Worker BHERT Member per barangay Barangay Public Safety Officer per barangay

Section 2. ROLES AND FUNCTIONS

The CTT shall have the following roles and functions:

1. Conduct contact tracing for all person with known exposure to a COVID-19 patient to ensure that they are strictly observing the home-quarantine measures;

2. Monitor that status of the Persons Under Investigation (PUI), Persons Under Monitoring (PUM), family members with known contact to a confirmed case to mitigate possibility of contagion; and
3. Report daily updates to the COVID19 Provincial and Regional Task Forces

Section 3. EFFECTIVITY

This order shall take effect immediately.
