**CREATION OF THE MUNICIPAL TASK FORCE ON ROAD CLEARING OF ILLEGAL STRUCTURES AND
CONSTRUCTIONS FOR THE MUNICIPALITY OF PURA, TARLAC**

WHEREAS, Republic Act 11494 or the Bayanihan to Recover as One Act provides: "Section 4. COVID-19 Response and Recovery Interventions- xxx. (II) regulation of traffic on all roads, streets, and bridges, and access thereto; prohibit putting up of encroachments or obstacles; authorize the removal of encroachments and illegal constructions in public places; and perform all other related acts; xxx."

WHEREAS, DILG Memorandum Circular No 2020-145 provides for the resumption of road clearing operation depending on the quarantine classification of the local government units, giving 60 calendar days for local government units to comply with the Presidential directive;

WHEREAS, all road clearing-related policies and undertakings shall be implemented and conducted without prejudice to the LGU's COVID-19 containment efforts and initiatives. Likewise, enforcement agents of the LGU shall observe minimum public health standards in all activities conducted in the compliance with this Memorandum Circular. Whenever possible, conduct of road clearing-related meetings, sessions and other coordination activities shall be done virtually;

WHEREAS, the prohibition on tricycles along national roads and highways, as provided for in DILG Memorandum Circular 2020-036, shall continue to be implemented, notwithstanding the rules and guidelines set by the Department of Transportation on the operation of tricycles during the community quarantine period. It is hereby reminded on the responsibilities set forth under MC 2020-036, including the creation of Tricycle Task Force and the drafting and updating of tricycle route plan;

NOW THEREFORE, I **FREDDIE DIAMSAY DOMINGO**, Municipal Mayor of Pura, Tarlac, by virtue of the powers vested upon me by law do hereby order.

Section 1. Creation of Municipal Task Force on Road Clearing (TFRC) of Illegal Structures and Constructions for the Municipality of Pura, Tarlac. The Municipal TFRC is hereby composed of the following:

Section 2: Duties and Functions. The Municipal TFRC shall perform the following functions:

- a. To conduct and prepare an inventory (identification and survey) of all public roads and streets within its jurisdiction;
- b. To properly relocate all affected households with illegal dwelling or parking spaces, business establishments, make-shift sari-sari stores and similar enterprises that have been displaced during the road clearing operations;
- c. To recommend rehabilitation of all recovered public roads by placing street names and street lights, among others;
- d. To revoke permits that give authority to private entities to occupy public roads, alleys and other thoroughfares;
- e. To revisit local ordinances and similar legislative measures to ensure responsiveness to this presidential directive and consistency with related laws and policies and to check whether there is a need to amend ordinances regarding illegal structures which are located in the "no obstruction zones";
- f. To ensure effective and immediate implementation of road clearing operations in the municipality; and
- g. To submit weekly update reports to the DLIG Provincial and Regional Offices.

SECTION 3. Repealing Claus. All issuances, and other executive orders which are consistent with or contrary with this Executive Order are hereby repealed, amended or modified accordingly.

SECTION 4. Effectivity. This order shall take effect immediately.
