**EXECUTIVE ORDER NO. 02-a**  
*Series of 2021*

**AN ORDER APPOINTING MR. FELICIANO C. LAMBUS TO ACT AS THE OFFICE OF THE SENIOR CITIZEN AFFAIRS (OSCA) HEAD IN THE MUNICIPALITY PURA**

**WHEREAS**, *Republic Act No. 9994*, otherwise known as the "*Expanded Senior Citizen's Act of 2010*" states that The Office of the Mayor shall exercise supervision over the OSCA relative to their plans, activities and programs for senior citizens. The OSCA shall work together and establish linkages with accredited NGOs Pos and the barangays in their respective areas (Sec. 6);

**WHEREAS**, Section 6 of R.A. 9994 states that there shall be established in municipalities an OSCA to be headed by a senior citizen who shall be appointed by the mayor for a term of three (3) years without reappointment but without prejudice to an extension if exigency so requires. Said appointee shall be chosen from a list of three (3) nominees as recommended by a general assembly of senior citizens organizations in the city or municipality. It further states that the head of the OSCA shall be appointed to serve the interest of senior citizens and shall not be removed or replaced except for reasons of death permanent disability or ineffective performance of his duties to the detriment of fellow senior citizens;


**WHEREAS**, incumbent OSCA Head, IRENEO C. GUZMAN, recently has not been able to perform fully and effectively his functions as OSCA head by reason of his health conditions;

**WHEREAS**, due to the directives of the National Government prohibiting Senior Citizens from going out of their residence and the prohibition on mass gatherings, the OSCA cannot call for a General Assembly for the purpose of electing and replacing the incumbent OSCA head as prescribed in the above-mentioned provision of the law;

**WHEREAS**, the OSCA, through its Board of Trustees and Officers deems it imperative to appoint a temporary OSCA Head who will perform the functions prescribed in R.A. 9994. The Board of Trustees, on a special meeting held on February 1, 2021, issued **Board Resolution No. 1** unanimously endorsing the appointment of Mr. Feliciano Lambus as the new OSCA head in the Municipality of Pura, consequently replacing Mr. Ireneo Guzman;

**NOW THEREFORE**, by virtue of the authority granted by law, I, **FREDDIE D. DOMINGO**, Municipal Mayor of Pura, Tarlac, hereby **APPOINT MR. FELICIANO C. LAMBUS** to act as the OSCA Head in the Municipality of Pura until such time that a new OSCA Head is Elected by the OSCA General Assembly;
