



EXECUTIVE ORDER NO. 2021-19
Series of 2021

**AN ORDER ALLOWING THE LIMITED RESORT OPERATION IN THE
MUNICIPALITY AND PROVIDING GUIDELINES THEREFORE**

By the power vested in me by law, I, **FREDDIE D. DOMINGO**, Municipal Mayor of Pura, Tarlac, hereby issue the foregoing Executive Order:

SECTION 1. RESUMPTION OF OPERATION. Resorts in the Municipality are hereby allowed to operate effective July 01, 2021.

SECTION 2. DEFINITIONS. For purposes of this order, the following shall mean:

RESORT – a place that is a popular destination for vacations or recreation, or which is frequented for a particular purpose;

SECTION 3. OPERATIONAL GUIDELINES.

- a. The operation of resorts in the Municipality is allowed provided, resort owners shall strictly adhere to the following:
 1. Resort owners shall apply from the Department of Tourism (DOT) Certificate of Authority to Operate and Safety Seal;
 2. 2021 Mayor's Permit for Business;
 3. The **CERTIFICATE OF AUTHORITY TO OPERATE and SAFETY SEAL** shall be posted at the entrance of the resort showing that the resort has complied with the minimum requirements set forth.
 4. It shall observe at all times a 70% capacity.
 5. The resort shall be made available at per family or group booking/scheduling and is prohibited to accommodate more than one family or group in a day, with the strict observance of the 70% capacity. All guests shall pre-book with the resort management prior to its entry. No walk-in guests shall be allowed. Minor guest may be allowed provided they are accompanied by their parents/guardians.
 6. Guests coming from outside the Municipality or Province and booking with the resort establishment for personal milestone celebration such as birthdays, weddings, baptism and the like shall be required to submit a Negative Antigen result from a registered health facility 24 hours prior to the event.
 7. Regular disinfection of the resort shall be done immediately after each booking.
 8. Strict Observance of curfew hours.

SECTION 4. BOOKING TERMINATION. The management of the resort can refuse entry of person/s or terminate booking of guest/s at the resort violating any of the minimum health standards and the rules of the establishment.

SECTION 5. IMPLEMENTATION. The Inter-agency Task Force (COVID-19) together with the BPLO, Philippine National Police-Pura MPS including BHERTS and BPATs where the resort is located is hereby authorized to implement this order.

SECTION 6. PENALTY. Resort owners who shall violate the provisions of this order shall be penalized under existing laws, including cancellation of business permit and denial of application and/or renewal of their business permit within a period of two (2) years from the date of violation.


SECTION 7. SUPPLETORY APPLICATION. All other issuances of the DILG and other National Government Agencies shall have suppletory application to this Executive Order;

SECTION 8. SEPARABILITY CLAUSE. Should any of this Executive Order be declared invalid for any reason, parts that are not affected shall remain valid;

SECTION 9. REPEALING CLAUSE. All other issuance inconsistent herewith are deemed modified accordingly;

SECTION 10. EFFECTIVITY. This Executive Order shall be effective immediately.
