**MUNICIPAL ORDINANCE NO. 004**

Series of 2015

**AN ORDINANCE CREATING THE POSITION OF MEDICAL TECHNOLOGIST I IN THE RURAL HEALTH UNIT OF THE MUNICIPALITY OF PURA, TARLAC**

WHEREAS, the local administration of Pura, Tarlac deems necessary the appointment of a medical technologist who shall be in charge of the laboratory works and facilities of the Municipal Health Office;

WHEREAS, for this purpose and guided by the prescribed Qualification Standards set by the Civil Service Commission, the Local Health Board recommends the creation of the positions of Medical Technologist I, Salary Grade 11/1, with monthly salary of P 13,912.00 for the local government unit of Pura, Tarlac;

NOW, THEREFORE, upon motion of Hon. Timoteo D. Balmares, duly seconded, be it ordained by the Sangguniang Bayan of Pura, Tarlac, in session assembled that:

**Section 1. Title.** This Ordinance shall be known as “*An Ordinance Creating the Position of Medical Technologist I in the Rural Health Unit of the Municipality of Pura, Tarlac*”.

**Section 2. Purpose.** To meet the needs of the present demands of a very functional and responsive Rural Health Unit, it is imperative to create the position of Medical Technologist I, Salary Grade 11, with monthly salary of P 13,912.00, in the organizational structure and staffing pattern of the LGU.

**Section 3. Qualifications, Powers and Duties/Responsibilities.** – The qualifications, powers, duties and responsibilities of the herein created position shall be based on the provisions of the Local Government Code and Civil Service Commission (CSC) rules, laws and regulations.

**Section 4. Appointment.** – The appointments for those who will be occupying the herein mentioned positions shall be within the prescribed qualification standards and guidelines set by the Civil Service Commission (CSC) and other relevant laws.

**Section 5. Appropriation .** - Appropriate funds shall be incorporated in the LGU's annual budget for the effective and continuous implementation of this ordinance.

**Section 6. Repealing Clause.** – All ordinances, rules and regulations or parts thereof inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

**Section 7. Effectivity Clause.** – This ordinance shall take effect upon approval and compliance with the requirements set forth by law.


