**MUNICIPAL ORDINANCE NO. 006**

**AN ORDINANCE RECLASSIFYING PARCEL OF LAND COVERED BY TCT NO. 274455, CONSISTING OF ONE THOUSAND AND EIGHTY-EIGHT (1,088) SQUARE METERS, REGISTERED IN THE NAME OF AMADO PARCASIO, LOCATED AT BARANGAY SINGAT, PURA TARLAC**

Be it enacted by the Sangguniang Bayan in session duly assembled:

**Section 1. TITLE** – This ordinance shall be known as the “AN ORDINANCE RECLASSIFYING PARCEL OF LAND COVERED BY TCT NO. 274455, CONSISTING OF ONE THOUSAND EIGHTY-EIGHT (1,088) SQUARE METERS, REGISTERED IN THE NAME OF AMADO PARCASIO, LOCATED AT BARANGAY SINGAT, PURA TARLAC”

**Section 2. RECLASSIFICATION** – The parcels of land identified as Lot No. 680-D-7 of PSD 03-031156 covered by TCT NO. 274455 is hereby reclassified from Agricultural Land to Commercial Land.

**Section 3. MANNER OF UTILIZATION** - The subject land shall be strictly utilized in accordance with the Municipal Zoning Ordinance of Pura, Tarlac and other applicable laws, rules and regulations.

**Section 4. EFFECTIVITY** – This ordinance shall take effect upon its approval.
