MUNICIPAL ORDINANCE NO. 007

AN ORDINANCE RECLASSIFYING PARCEL OF LAND COVERED BY TCT NO. 215320, CONSISTING OF THREE HUNDRED TWENTY EIGHT (328) SQUARE METERS, REGISTERED IN THE NAME OF ROGELIO V. VALDEZ, LOCATED AT BARANGAY POBLACION 3, PURA TARLAC

Be it enacted by the Sangguniang Bayan in session duly assembled:

Section 1. TITLE – This ordinance shall be known as “AN ORDINANCE RECLASSIFYING PARCEL OF LAND COVERED BY TCT NO. 215320, CONSISTING OF THREE HUNDRED TWENTY EIGHT (328) SQUARE METERS, REGISTERED IN THE NAME OF ROGELIO V. VALDEZ, LOCATED AT BARANGAY POBLACION 3, PURA TARLAC”

Section 2. RECLASSIFICATION –

The parcels of land identified as Lot No. 753-E-2 of PSD 03-029226 covered by TCT NO. 215320 is hereby reclassified from Agricultural Land to Commercial Land.

Section 3. MANNER OF UTILIZATION - The subject land shall be strictly utilized in accordance with the Municipal Zoning Ordinance of Pura, Tarlac and other applicable laws, rules and regulations.

Section 4. EFFECTIVITY – This ordinance shall take effect upon its approval.
