APPROPRIATION ORDINANCE NO. 004
 Series of 2020

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 04, SERIES OF 2020, INVOLVING THE AMOUNT OF FOUR HUNDRED TWO THOUSAND FOUR HUNDRED NINETY SIX PESOS (P 402,496.00) FOR THE ADDITIONAL FUND FOR GRANT OF “HAZARD PAY” DURING THE ENHANCED COMMUNITY QUARANTINE RELATIVE TO THE CORONAVIRUS DISEASE 2019 PANDEMIC

WHEREAS, President Rodrigo Roa Duterte placed the entire Luzon under Enhance Community Quarantine to alleviate the spread of COVID-19;

WHEREAS, Administrative Order No. 26, dated March 23, 2020 authorizes the grant of Hazard Pay to employees who physically report for work during the implementation of the Enhanced Community Quarantine in their respective workstations;

NOW THEREFORE, on unanimous motion, be it enacted by the Sangguniang Bayan, that:

SECTION 1. TITLE. This Ordinance shall be known as “Supplemental Budget No. 04, Series of 2020”;

SECTION 2. SOURCE OF FUNDS. The source of funds for the Supplemental Budget in the total amount of **FOUR HUNDRED TWO THOUSAND FOUR HUNDRED NINETY SIX PESOS (P 402,496.00)** shall be as follows:
