**APPROPRIATION ORDINANCE NO. 006**

**AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 06, SERIES OF 2020, INVOLVING THE AMOUNT OF TWO HUNDRED FIFTY PESOS (P 250,000.00) SOURCED FROM SAVINGS FROM VARIOUS IMPLEMENTED PROJECTS FOR CY-2020 TO BE UTILIZED FOR THE PAYMENT OF BIDS AND AWARDS COMMITTEE (BAC) HONORARIUM**

WHEREAS, Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act" provides for the grant of honoraria to government personnel involved in the government procurement;

WHEREAS, DBM Budget Circular No. 2007-3 dated November 29, 2007, provides that payment of honorarium may be sourced from the Savings realized from the current year specific budget of the agency under the General Appropriation Act (GAA);

WHEREAS, the municipality has an accumulated savings from various implemented projects for the CY-2020 amounting to Two Hundred Seventy-Eight Thousand Seven Hundred Thirty Four (P 278,734.00);

WHEREAS, the Local Chief Executive sought the realignment of a Two Hundred Fifty Thousand (P 250,000.00) portion of the aforementioned amount for the payment of BAC honorarium;

NOW THEREFORE, on unanimous motion, be it enacted by the Sangguniang Bayan, that:

**SECTION 1. TITLE.** This Ordinance shall be known as "Supplemental Budget No. 06, Series of 2020";

**SECTION 2. SOURCE OF FUNDS.** The source of funds for the Supplemental Budget in the total amount of **TWO HUNDRED FIFTY PESOS (P 250,000.00)** shall be as follows:
