APPROPRIATION ORDINANCE NO. 007

Series of 2020

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 07, SERIES OF 2020, INVOLVING THE AMOUNT OF TWO HUNDRED EIGHTY NINE THOUSAND PESOS (P 289,000.00) FOR THE GRANT OF “HAZARD PAY” FOR THE HEALTH CARE WORKERS AND OTHER PERSONNEL FROM THE PURA RURAL HEALTH UNIT (RHU) DURING THE COMMUNITY QUARANTINE RELATIVE TO THE MANAGEMENT OF CORONAVIRUS DISEASE 2019

WHEREAS, President Rodrigo Roa Duterte placed the entire Luzon under Community Quarantine to alleviate the spread of COVID-19. In connection, the National Task Force, the Provincial Task Force and the Municipal Task Force have implemented numbers of health and travel protocols;

WHEREAS, because of the obvious health risk faced by the healthcare workers and personnel of the Rural Health Unit (RHU), the local government deems it reasonable to grant Hazard Pay to said frontliners who physically report for work;

NOW THEREFORE, on unanimous motion, be it enacted by the Sangguniang Bayan, that:

SECTION 1. TITLE. This Ordinance shall be known as “Supplemental Budget No. 07, Series of 2020”;

SECTION 2. SOURCE OF FUNDS. The source of funds for the Supplemental Budget in the total amount of **TWO HUNDRED EIGHTY NINE THOUSAND PESOS (P 289,000.00)** shall be sourced from the General Fund, particularly from the Savings from the Vacant Positions in the Personal Services (PS) as follows:

SECTION 3. USE OF FUNDS. The amount of **TWO HUNDRED EIGHTY NINE THOUSAND PESOS (P 289,000.00)** shall be utilized for the grant of Hazard Pay to for the Health Care Workers and other personnel from the PURA RURAL HEALTH UNIT (RHU) who physically reported for work during the community quarantine relative to the management of Coronavirus Disease 2019.


SECTION 5. EFFECTIVITY. This Ordinance shall take effect upon approval.


