APPROPRIATION ORDINANCE NO. 008

Series of 2020

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 08, SERIES OF 2020, INVOLVING THE AMOUNT OF SEVEN HUNDRED NINETY THREE THOUSAND ONE HUNDRED TWENTY FIVE PESOS (P 793,125.00) FOR THE VARIOUS EXPENDITURES OF THE MUNICIPALITY

WHEREAS, programs, projects and activities in the budget documents showed substantial compliance on all budgetary requirements and general limitation stipulated in the provisions of the Local Government Code of 1991 and other laws, rules and regulation;

WHEREAS, the Municipality of Pura has an income amounting to **SEVEN HUNDRED NINETY THREE THOUSAND ONE HUNDRED TWENTY FIVE PESOS (P 793,125.00)** from the Internal Revenue Allotment (IRA);

WHEREAS, the said amount shall be utilized for the additional appropriation of various expenditures of the Municipality;

NOW THEREFORE, on unanimous motion, be it enacted by the Sangguniang Bayan, that:

SECTION 1. TITLE. This Ordinance shall be known as “Supplemental Budget No. 08, Series of 2020”;

Section 2. Source of Funds. The source of funds for the Supplemental Budget in the total amount of **SEVEN HUNDRED NINETY THREE THOUSAND ONE HUNDRED TWENTY FIVE PESOS (P 793,125.00)** shall be as follows:
