MUNICIPAL ORDINANCE NO. 005

AN ORDINANCE RECLASSIFYING PARCEL OF LAND COVERED BY TCT NO. 043-2019013302, CONSISTING AN AREA OF FOUR THOUSAND THREE HUNDRED TWENTY NINE (4,329) SQUARE METERS, LOCATED AT BARANGAY ESTIPONA, PURA, TARLAC, REGISTERED IN THE NAME OF MARY ANN PUNZALAN CORPUZ, FROM AGRICULTURAL LAND TO A COMMERCIAL LAND

Be it enacted by the Sangguniang Bayan in session duly assembled:

Section 1. TITLE – This ordinance shall be known as “*AN ORDINANCE RECLASSIFYING PARCEL OF LAND COVERED BY TCT NO. 043-2019013302, CONSISTING AN AREA OF FOUR THOUSAND THREE HUNDRED TWENTY NINE (4,329) SQUARE METERS, LOCATED AT BARANGAY ESTIPONA, PURA, TARLAC, REGISTERED IN THE NAME OF MARY ANN PUNZALAN CORPUZ, FROM AGRICULTURAL LAND TO A COMMERCIAL LAND*”.

Section 2. RECLASSIFICATION – That parcel of land covered by TCT NO. 043-2019013302, with a total land area of *FOUR THOUSAND THREE HUNDRED TWENTY NINE (4,329)* square meters, located at Barangay Estipona, Pura, Tarlac, is hereby reclassified from Agricultural to Commercial Land.

Section 3. MANNER OF UTILIZATION - The subject land shall be strictly utilized in accordance with the Municipal Zoning Ordinance of Pura, Tarlac and other applicable laws, rules and regulations.

Section 4. EFFECTIVITY– This ordinance shall take effect upon its approval.
