MUNICIPAL ORDINANCE NO. 008

AN ORDINANCE RECLASSIFYING PARCEL OF LAND COVERED BY TCT NO. 49166, CONSISTING AN AREA OF TWENTY SIX THOUSAND THREE HUNDRED EIGHTY FIVE (26,385) SQUARE METERS, LOCATED AT BARANGAY MAUNGIB, PURA, TARLAC, REGISTERED IN THE NAME OF LOUIE ANTHONY S. DASALLA, FROM AGRICULTURAL LAND TO A RESIDENTIAL ZONE

Be it enacted by the Sangguniang Bayan in session duly assembled:

Section 1. TITLE – This ordinance shall be known as “*AN ORDINANCE RECLASSIFYING PARCEL OF LAND COVERED BY TCT NO. 49166, CONSISTING AN AREA OF FOUR THOUSAND EIGHT HUNDRED SIXTY ONE (4,861) SQUARE METERS, LOCATED AT BARANGAY MAUNGIB, PURA, TARLAC, REGISTERED IN THE NAME OF LOUIE ANTHONY S. DASALLA, FROM AGRICULTURAL LAND TO A RESIDENTIAL ZONE*”.

Section 2. RECLASSIFICATION – That parcel of land covered by TCT NO. 49166, with a total land area of *FOUR THOUSAND EIGHT HUNDRED SIXTY ONE (4,861)* square meters, located at Barangay Maungib, Pura, Tarlac, is hereby reclassified from Agricultural to Residential Zone.

Section 3. MANNER OF UTILIZATION - The subject land shall be strictly utilized in accordance with the Municipal Zoning Ordinance of Pura, Tarlac and other applicable laws, rules and regulations.

Section 4. EFFECTIVITY– This ordinance shall take effect upon its approval.
