AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET AMOUNTING TO ONE HUNDRED SIXTY-EIGHT THOUSAND PESOS (P 168,000.00) FOR THE RELEASE GRATUITY PAY TO CONTRACT OF SERVICE AND JOB ORDER WORKERS IN THE MUNICIPALITY FOR FY 2021 PURSUANT TO ADMINISTRATIVE ORDER NO. 46, DATED DECEMBER 29, 2021, BY THE OFFICE OF THE PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES

WHEREAS, the Office of the President of the Republic of the Philippines issued Administrative Order No. 46, dated December 29, 2021, Authorizing the Grant of Gratuity Pay to Contract of Service and Job Order Workers in the Government for Fiscal Year 2021;

WHEREAS, said Administrative Order Authorized the grant of Gratuity Pay to Contract of Service and Job Order Workers in the Government who have rendered a total or aggregate of at least four months of service as of December 15, 2021 can avail of not more that P 5,000 gratuity pay. Those who have rendered less than four months may also be granted the one-time pay on a pro rata basis;

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED, by the Sangguniang Bayan in a Special Session, that:

SECTION 1. RELEASE OF GRATUITY PAY FOR FY 2021. The Sangguniang Bayan of Pura hereby authorizes the release of Gratuity Pay to Contract of Service and Job Order Workers in the Municipal Government of Pura pursuant to Administrative Order No. 46 dated December 29, 2021 by the Office of the President;

SECTION 2. SOURCE OF FUND. The amount of ONE HUNDRED SIXTY-EIGHT THOUSAND PESOS (P 168,000.00) detailed below is available and existing as certified by the Municipal Budget Officer:
