MUNICIPAL ORDINANCE NO. 008

Series of 2021

AN ORDINANCE MODIFYING NURSE II POSITION WITH SALARY GRADE 15 (STEP 1) TO NURSE II WITH SALARY GRADE 16 (STEP 1)

WHEREAS, the Department of Budget and Management (DBM) issued Budget Circular No. 2021-2 that provided rules and regulations on the upgrading of previous Nurse II positions by one (1) SG;

WHEREAS, the Circular covers all previous Nurse II to Nurse VII positions, which attributes were modified pursuant to DBM BC No. 2020-4;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED by the Sangguniang Bayan, in session assembled, that:

SECTION 1. TITLE – This shall be known as the “Nurse II Modification Ordinance”

SECTION 2. MODIFICATION OF NURSE POSITION - The Nurse II position in the Municipality is hereby modified as follows:

FROM		TO	
NURSE II	SG 15, Step 1	NURSE II	SG 16, Step 1

SECTION 3. SEPARABILITY - If any provision of this ordinance is found invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the remaining or other provisions of this ordinance.

SECTION 4. REPEALING CLAUSE – All ordinances, executive orders, proclamations and administrative regulations, or part or parts thereof, which are inconsistent with any of the provision of this Ordinance are hereby repealed or modified accordingly.

SECTION 5. EFFECTIVITY / RETROACTIVITY – This ordinance shall take effect upon its approval. However, the effect on the modification, particularly on the salary grade, shall apply retroactively to June 1, 2021, pursuant to DBM Circular 2021-2.
