APPROPRIATION ORDINANCE NO. 001

AN ORDINANCE PRESCRIBING THE UTILIZATION/USE OF THE APPROPRIATED SUPPORT FUND FOR THE IMPLEMENTATION OF PEACE AND ORDER AND PUBLIC SAFETY PROGRAMS PROJECTS AND ACTIVITIES IN THE ANNUAL BUDGET F.Y. 2022 OF THE MUNICIPALITY

WHEREAS, the Sangguniang Bayan passed Appropriation Ordinance No. 002, Series of 2021, authorizing the Annual Budget of the Municipality FY 2022 on December 14, 2021;

WHEREAS, a Special Purpose Appropriation amounting to **Five Hundred Thousand Pesos (P500,000.00)** and another **Two Hundred Thousand Pesos (P 200,000.00)** from the GAD Fund was appropriated under the Office of the Mayor as Support Fund for the Implementation of Peace and Order and Public Safety Programs Projects and Activities in the Annual Budget F.Y. 2022 of the Municipality;

WHEREAS, the Sangguniang Bayan passed a resolution adopting the Peace and Order & Public Safety (POPS) Plan FY 2020-2022;

WHEREAS, the said POPS plan include matrix on Priority Issues in the Municipality, to wit: Drug Abuse, Robbery, Theft, CICL, Vehicular Accidents and Illegal Gambling;

WHEREAS, in order the address the above mentioned priority issues, appropriate funding is necessary;

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN IN SESSION DULY ASSEMBLED, THAT:

SECTION 1. USE OF SUPPORT FUND FOR THE IMPLEMENTATION OF PEACE AND ORDER AND PUBLIC SAFETY PROGRAMS PROJECTS AND ACTIVITIES. The amount of **Seven Hundred Thousand Pesos (P 700,000.00)** allocated as Support Fund for the Implementation of

Peace and Order and Public Safety Programs Projects and Activities in the Annual Budget F.Y. 2022 of the Municipality shall be utilized/used as follows:
