APPROPRIATION ORDINANCE NO. 002

Series of 2022

AN ORDINANCE AUTHORIZING THE SUPPLEMENTAL BUDGET NO. 01, SERIES OF 2022, INVOLVING THE AMOUNT OF ONE MILLION SIX HUNDRED FOUR THOUSAND TWO HUNDRED FIFTY PESOS (P 1,604,250.00) FOR THE VARIOUS EXPENDITURES OF THE MUNICIPALITY

WHEREAS, programs, projects and activities in the budget documents showed substantial compliance on all budgetary requirements and general limitation stipulated in the provisions of the Local Government Code of 1991 and other laws, rules and regulation;

WHEREAS, the Municipality of Pura has a savings amounting to One Million Six Hundred Four Thousand Two Hundred Fifty Pesos (P 1,604,250.00) from the Trust Fund (LDRRM);

WHEREAS, the said amount shall be utilized for the additional appropriation of various expenditures of the Municipality;

NOW THEREFORE, on unanimous motion, be it enacted by the Sangguniang Bayan, that:

SECTION 1. TITLE. This Ordinance shall be known as “Supplemental Budget No. 01, Series of 2022”;

Section 2. Source of Funds. The source of funds for the Supplemental Budget in the total amount of **ONE MILLION SIX HUNDRED FOUR THOUSAND TWO HUNDRED FIFTY PESOS (P 1,604,250.00)** shall be as follows:
