**AN ORDINANCE CONVERTING DON TEODORICO PASCUAL PRIMARY SCHOOL INTO AN ELEMENTARY SCHOOL AND RENAMING IT FROM “DON TEODORICO PASCUAL PRIMARY SCHOOL” TO “CADANGLAAN ELEMENTARY SCHOOL”**

WHEREAS, Don Teodorico Pascual Primary School has been qualified for conversion into Elementary School and such conversion was duly approved by the Local School Board of Pura;

WHEREAS, Don Teodorico Pascual Primary School, through its Principal Lani Mislang, T-III/OIC, requested for a Local Ordinance converting Don Teodorico Pascual Primary School into an Elementary School and to rename it from “Don Teodorico Pascual Primary School” to “Cadanglaan Elementary School”;

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of Pura in Regular Session Assembled:

**SECTION 1. Title** - This ordinance shall be called “Cadanglaan Elementary School Ordinance of 2022”;

**SECTION 2. Conversion and Renaming** - Don Teodorico Pascual Primary School is hereby converted into an Elementary School and shall now be called “CADANGLAAN ELEMENTARY SCHOOL”;

**SECTION 3. Effectivity** - This ordinance shall take effect immediately upon its approval.
