**AN ORDINANCE CONVERTING SINGAT PRIMARY SCHOOL INTO AN ELEMENTARY SCHOOL AND RENAMING IT FROM “SINGAT PRIMARY SCHOOL” TO “SINGAT PURA ELEMENTARY SCHOOL”**

WHEREAS, Singat Primary School has been qualified for conversion into Elementary School and such conversion was duly approved by the Local School Board of Pura;

WHEREAS, Singat Primary School, through its Principal Haidee I. Estioko, T-III/OIC, requested for a Local Ordinance converting Singat Primary School into an Elementary School and to rename it from “Singat Primary School” to “Singat Pura Elementary School”;

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of Pura in Regular Session Assembled:

**SECTION 1. Title** - This ordinance shall be called “Singat Pura Elementary School Ordinance of 2022”;

**SECTION 2. Conversion and Renaming** - Singat Primary School is hereby converted into Elementary School and shall now be called “SINGAT PURA ELEMENTARY SCHOOL”;

**SECTION 3. Effectivity** - This ordinance shall take effect immediately upon its approval.
