A RESOLUTION DESIGNATING THE PURA COVERED COURT AS THE TEMPORARY RELOCATION SITE FOR THE STALL OWNERS OF THE PUBLIC MARKET

WHEREAS, it has been decided by the Executive Department that the temporary relocation site for the stall-owners of the Pura Public Market will be the Pura Municipal Covered Court;

WHEREAS, pursuant to Section 11, par. (c), of Republic Act No. 7160, local government offices and facilities shall not be transferred, relocated or converted to other uses unless public hearings are first conducted for the purpose and the concurrence of the majority of all the members of the sanggunian concerned is obtained;

WHEREAS, in compliance thereto, the Committee on Public Utilities and Facilities, Market and Slaughterhouse, in coordination with the Committee on Rules, Privileges and Legal Matters, conducted the necessary public hearing in January 2011 at the Pura Municipal Training Center;

NOW THEREFORE, upon the recommendation of the concerned committees of this August body, be it:

RESOLVED, as it is hereby resolved, to designate the Pura Municipal Covered Court as the temporary relocation site for the stall-owners of the market vendors of this Municipality.

RESOLVED FURTHER, to furnish copies of this resolution to all agencies concerned for their perusal and guidance.
