RESOLUTION ENJOINING THE CONCERNED MUNICIPAL OFFICIAL/S TO FORMULATE THE NECESSARY GUIDELINES FOR THE PROPER UTILIZATION OF THE MUNICIPAL AMBULANCE AND OTHER VEHICLES

WHEREAS, it is a policy that funds and monies of the local government units must be duly protected to ensure proper use thereof and, thus, meet the needs and demands of the people in the administration of public affairs;

WHEREAS, it has been noted by this body that there had been significant increase in our gasoline expense for this fiscal year;

WHEREAS, the lack of proper guidelines in the proper utilization of the ambulance and other vehicles resulted in the early depletion of the budget for “fuel, lubricant and oil expense”; thus, the need for augmentation;

NOW THEREFORE, on unanimous motion presented, be it:

RESOLVED, as it is hereby resolved, to enjoin the concerned Municipal Official/s to formulate the necessary guidelines for the proper use of the Municipal ambulance and other vehicles.

RESOLVED FURTHER, that copy of this resolution be furnished to the Local Chief Executive for her information and guidance.
