RESOLUTION GRANTING AUTHORITY TO THE LOCAL CHIEF EXECUTIVE TO DISPOSE THROUGH PUBLIC AUCTION THE SCRAP MATERIALS OF THE EXISTING WET MARKET

WHEREAS, the Honorable Enrique M. Cojuangco, Congressman, First District of Tarlac, has provided the Municipality the amount of **THREE MILLION PESOS (P3,000,000.00)** for the construction of a new Wet Market;

WHEREAS, the proposed site thereof will be the same with existing wet market; hence, the need to dispose the latter to pave the way for the construction of a new one;

WHEREAS, in order to achieve uniformity and consistency in the observance of audit procedures and to ensure facility in audit with respect to the divestment or disposal of property and other assets of the National Government Agencies/Instrumentalities, local government units and government-owned corporations and the subsidiaries, COA Circular No. 89-296 was issued;

WHEREAS, pursuant to paragraph IV of the said Circular, the full and sole authority and responsibility for the divestment or disposal of property and other assets owned by national government agencies or instrumentalities, local government units, shall be lodged to the heads of the concerned agencies or instrumentalities;

NOW THEREFORE, on unanimous motion presented, be it:

RESOLVED, as it is hereby resolved, to grant authority to the Honorable Concepcion A. Zarate, Municipal Mayor, to dispose through public auction the existing Wet Market subject to the provisions of COA Circular No. 89-296 and other related laws.
