A RESOLUTION DECLARING THE ENTIRE MUNICIPALITY OF PURA, TARLAC UNDER THE STATE OF CALAMITY

WHEREAS, due to the onslaught of Typhoons Pedring and Quiel, many low-lying areas in this Municipality were deeply flooded, causing massive damages to crops and livestock and other properties and evacuation of residents in this Municipality;

WHEREAS, the Municipal Government is desirous of extending assistance to the victims or mitigating the effects of the said calamities;

WHEREAS, pursuant to the provisions of the Local Government Code of 1991, as amended, the Sangguniang Bayan is empowered to declare the municipality or any part thereof under the state of calamity;

NOW THEREFORE, on unanimous motion presented, be it:

RESOLVED, as it is hereby resolved, to declare the entire Municipality of Pura, Tarlac under the STATE OF CALAMITY and hereby authorizes the utilization of the Municipality's calamity fund or the Municipal Disaster Risk Reduction and Management Fund for relief and recovery programs, rehabilitation, risk reduction and disaster-preparedness and post-disaster activities and for other necessary and pertinent programs and activities allowed by law;

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and appropriate action.
