A RESOLUTION RESPECTFULLY REQUESTING HIS EXCELLENCY, PRESIDENT BENIGNO SIMEON C. AQUINO III, TO PROVIDE FUNDS FOR THE DESILTATION OF THE SUSUBAEN CREEK IN BARANGAYS BUENAVISTA, MAASIN, MAUNGIB AND CADANGLAAN, THIS MUNICIPALITY

WHEREAS, one of the perennial problems in this Municipality is **flooding**, which was mainly brought about by the Siltation of the Susabaen Creek in Barangays Buenavista, Maasin, Maungib and Cadanglaan;

WHEREAS, due to the scarcity of funds or limited financial resources of this local government unit (LGU), the Desiltation of the said Creek has not yet been undertaken;

WHEREAS, due to the said predicament, it is imperative upon this LGU to seek financial assistance from the national government agencies, particularly the Office of the President;

NOW THEREFORE, on motion of Coun. Felino C. Millo Jr., Chairman, Committee on Rules, Privileges and Legal Matters, unanimously seconded, be it:

RESOLVED, as it is hereby resolved, to respectfully request the Office of the President to provide funds for the Desiltation of the Susabaen Creek in Barangays Buenavista, Maasin, Maungib and Cadanglaan, this Municipality;
