**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR AND THE ACTING  
MUNICIPAL TREASURER AS THE OFFICIAL SIGNATORIES, FOR AND ON BEHALF OF  
THE PURA MUNICIPAL GOVERNMENT IN ALL BUSINESS TRANSACTIONS WITH THE  
LAND BANK OF THE PHILIPPINES, PHILIPPINE NATIONAL BANK AND DEVELOPMENT  
BANK OF THE PHILIPPINES**

WHEREAS, Section 444, par. (b) (1) (vi), of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991," provides that for efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, pursuant to Section 470, par. ( d ) ( 2 ), of the said Code also provides that the treasurer shall take charge of the treasury office, perform the duties provided for under Book II of the Code, and shall take custody and exercise proper management of the funds of the local government unit concerned;

WHEREAS, in view of the foregoing, there is a necessity to authorize the Municipal Mayor, **Hon. CONCEPCION A ZARATE**, and Acting Municipal Treasurer, **MRS. LORNA M. ARIBE**, as the official signatories of all business transactions of this local government unit with the Land Bank of the Philippines, Philippine National Bank and Development Bank of the Philippines;

NOW THEREFORE, on unanimous motion presented, be it:

WHEREAS, Section 444, par.
