A RESOLUTION FORGING A SISTER-CITY RELATIONSHIP AND TWINNING AGREEMENT WITH THE CITY OF MAKATI TO FOSTER AND PROMOTE EXCHANGES IN VARIOUS FIELDS OF ENDEAVOURS AS MAY BE AGREED UPON, LIKEWISE GRANTING AUTHORITY TO THE MUNICIPAL MAYOR TO SIGN THE DOCUMENTS THAT MAY BE ENTERED INTO, FOR AND ON BEHALF OF THE MUNICIPALITY

WHEREAS, Local Government Units (LGU's) nationwide are urged to explore more opportunities for twinning partnerships with their LGU counterparts here and abroad as a means to promote goodwill and understanding, as well as other socio-cultural and economic aspects of development;

WHEREAS, because of rapid urbanization, LGU's should now consider other equally pressing concerns and issues in their twinning agreements which can be mutually beneficial to them;

WHEREAS, sister-city or town-twinning is the highest form of inter-LGU partnership, in-country or abroad, which enables partner communities or local authorities to implement mutually-beneficial activities:

WHEREAS, the Department of the Interior and Local Government, through the Bureau of Local Government Supervision, has gone a long way in promoting sisterhood and twinning relationships from the time the Sister City or Town Affiliation Program was conceived in 1982 to the time the Philippine International Sisterhood and Twinning Association (PHISTA) was born in 1986;

WHEREAS, technical exchanges and cooperation program among (LGUs) through sisterhood and twinning relationship upholds to promote mutual understanding and goodwill on the multifarious dimension of local governance thereby assuring its inhabitants peace, stability and prosperity, today and beyond;
