**A RESOLUTION MANIFESTING THE INTENTION OF THE MUNICIPALITY OF PURA TO RENEW ITS AVAILMENT OF THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP) SALARY LOAN FACILITY AND AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO AND SIGN, FOR AND IN BEHALF OF THE MUNICIPALITY, A MEMORANDUM OF AGREEMENT WITH THE DBP AND IN OTHER PERTINENT DOCUMENTS IN CONNECTION WITH THE SAID AVAILMENT**

WHEREAS, DBP has launched a salary loan facility of providing financial assistance in the form of salary loans to qualified officers and employees of the participants accordance with the DBP Consumer Lending for Government Agency/GOCC/Local Government Units/Electric Cooperatives/Local Water District Officers and Employees;

WHEREAS, the Municipality of Pura has previously availed of the said Salary Loan Facility;

WHEREAS, in consideration of DBP's agreement to extend salary loan facility to the Municipality of Pura, the latter agreed to renew its availment;

WHEREAS, in a hearing held by the Committee of on Rules, Privileges and Legal Matters of the Sangguniang Bayan, the Memorandum of Agreement in connection with the aforementioned salary loan facility was found to be proper and justifiable;

NOW THEREFORE, on motion duly seconded by all the members of the Sangguniang Bayan present, be it:

RESOLVED, as it is hereby resolved, to authorize the Municipal Mayor to enter into and sign, for and in behalf of the Municipality, a Memorandum of Agreement with the Development Bank of the Philippines (DBP) and other pertinent documents regarding the Salary Loan Facility.
