A RESOLUTION ADOPTING/APPROVING THE LOCAL ANTI-CRIMINALITY ACTION PLAN (LACAP): “MASAGANANG ANI”, TO ADDRESS FELONIES PERPETRATED BY DECEITFUL MOBILE GRAIN BUYERS IN THE MUNICIPALITY

WHEREAS, the Sangguniang Bayan of Pura received a resolution from the Pura Municipal Peace and Order Council (MPOC) endorsing, for approval, the Local Anti-Criminality Action Plan: “Masaganang Ani” (LACAP), submitted by the Philippine National Police-Pura Municipal Police Station pursuant to NHQ PNP LOI 71/08 “Payapa” and NHQ PNP LOI 70/08 “Local Anti-Crime Strategy”;

WHEREAS, the said LACAP prescribes the concepts, guidelines and procedure in the conduct of intensified police operations and holistic approach to suppress the occurrence of felonies brought about by deceitful mobile grain buyers during the period of crop harvesting season within the municipality;

WHEREAS, in response to the said endorsement, the Sangguniang Bayan, spearheaded by the Committee on Peace and Order and Public Safety, conducted a committee hearing and deems it necessary to adopt the said LACAP considering the present situation of the municipality;

NOW THEREFORE, on motion by Councilor Freddie Domingo, duly seconded, it is hereby **RESOLVED** to adopt/approve the Local Anti-Criminality Action Plan (LACAP): “Masaganang Ani” in the Municipality of Pura.


RESOLVED FURTHER, to urge the Office of the Local Chief Executive to order the PNP-PURA to strictly implement the Revised Revenue Code of Pura, specifically the provisions regarding ambulant traders of agricultural products (Chapter III., Article O., Section 30.01);
