A RESOLUTION REALIGNING THE AMOUNT OF FOUR HUNDRED TWENTY FIVE THOUSAND FIVE HUNDRED EIGHTY FIVE AND 51/100 PESOS (P425, 585.51) FROM THE IMPLEMENTED PROJECTS UNDER THE 20% EDF FOR FY 2016 TO FINANCE THE VARIOUS PRIORITY PROJECTS OF THE MUNICIPALITY

WHEREAS, the municipality has savings from the implemented projects under the 20% Economic Development Fund for Fiscal Year 2016 in the amount of **FOUR HUNDRED TWENTY FIVE THOUSAND FIVE HUNDRED EIGHTY FIVE AND 51/100 PESOS (P425,585.51)**;

WHEREAS, the municipality has identified various priority projects to be implemented;

WHEREAS, there is a need to realign the above-mentioned savings to finance the various priority projects of the municipality;

NOW THEREFORE, on unanimous motion presented, be it:


