A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE EARLY CHILDHOOD CARE AND DEVELOPMENT (ECCD) COUNCIL FOR THE ESTABLISHMENT OF A NATIONAL CHILD DEVELOPMENT CENTER (NCDC) IN THE MUNICIPALITY OF PURA

WHEREAS, the EARLY CHILDHOOD CARE AND DEVELOPMENT (ECCD) COUNCIL is duly mandated in accordance with Republic Act No. 10410, otherwise known as the “*Early Years Act to Institutionalize a National System for Early Childhood Care and Development*”;

WHEREAS, as provided in the aforementioned Act, the ECCD Council is mandated to establish a National Child Development Centers (NCDC’s) and convert selected existing Day Care Centers into Child Development Centers;

WHEREAS, such ECCD aims to further enhance the provision of the quality Home-based and Center-based ECCD programs by establishing National Child Development Centers in partnership with local government units;

WHEREAS, the Municipality of Pura was chosen to be one of the recipients of the said program;

WHEREAS, such partnership with the ECCD Council shall consist arrangement for the conduct of the ECCD Programs, which were embodied in the proposed Memorandum of Agreement (MOA) presented before the Sangguniang Bayan for its review;

NOW THEREFORE, on motion by Councilor John Paul M. Balmores, duly seconded, be it:


RESOLVED as it is hereby RESOLVED, to authorize the Local Chief Executive to enter into a Memorandum of Agreement (MOA) with the Early Childhood Care and Development (ECCD) Council, for the establishment of a National Child Development Center (NCDC) in the Municipality of Pura;
