RESOLUTION NO. 087

**A RESOLUTION GRANTING SPECIAL PERMIT TO THE SANGGUNIANG BARANGAY OF
POROC TO HOLD FUND-RAISING ACTIVITY THRU COCKFIGHTING**

WHEREAS, the members of the Sangguniang Barangay of Poroc, in their desire to continue providing recreation and entertainment and at the same time raise funds for its priority projects, are requesting for a Special Permit to hold fund-raising activity thru cockfighting;

WHEREAS, this body after careful deliberation agreed to grant a special permit to hold special cockfights starting on October 1, 2016;

NOW THEREFORE, on motion of Councilor Bernabe P. Idmilao, Chairman, Committee on Games and Amusement, duly seconded, be it:

RESOLVED, as it is hereby resolved, to grant a Special Permit to the Sangguniang Barangay of Poroc, Pura, Tarlac, to hold special cockfights, subject to the following terms and conditions, viz:

1. The fund-raising activity thru cockfighting shall conform with the provisions of Section 391, par. (11), of Republic Act No.7160 to ensure compliance with national policy standards and regulation on morals, health and safety of the persons participating therein.
2. Cockfights shall be conducted in accordance with the rules and regulations set forth in Municipal Ordinance No. 08-002 and other related laws.
3. Cockfights shall be managed by duly qualified persons who shall abide with the pertinent provisions of the Municipal Tax and Revenue Code.

4. No Gambling of any kind shall be permitted within the premises of the temporary cockpit.
5. This Special Permit shall be valid until December 8, 2016 only.

RESOLVED FURTHER, to furnish copies of this resolution to all agencies concerned for their information and guidance.
