**RESOLUTION NO. 088**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE OF PURA, TARLAC TO  
ENTER INTO AN AGREEMENT WITH THE BUREAU OF FIRE PROTECTION FOR THE  
RELEASE OF THE TWENTY PER CENT (20%) SHARE IN THE FIRE CODE REVENUES.**

WHEREAS, DOF-DBM-DILG Joint Circular No. 2015-01, dated February of the 12, 2015, authorized the release of Twenty Percent (20%) share in the Fire Code Revenues in concerned municipalities upon release of Special Allotment Release Order (SARO) Notice of Cash Allocation (NCA) from the DBM for collections for CY 2010, 2011, 2012 and 2013. CY 2014 and 2015 collections will be directly released by the DBM to the municipality;

WHEREAS, the municipality is mandated to appropriate the twenty percent (20%) share exclusively for the improvement and maintenance of the municipality BFP fire station;

WHEREAS, to ensure compliance of the said mandate, and to identify the obligation and rights of the proponents, there is a need to enter into an Agreement;

WHEREAS, a draft Memorandum of Agreement was referred to the Sangguniang Bayan, specifically to the Committee on Rules, Privileges and Legal Matters, for review and consideration;

WHEREAS, after a hearing by the Sanggunian, spearheaded by the Committee on Rules and Privileges and Legal Matters, the Sanggunian finds the provisions of the Memorandum of Agreement to be proper;


