A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE OF PURA, TARLAC TO ENTER INTO AN AGREEMENT WITH THE BUREAU OF SOILS AND WATER MANAGEMENT (BSWM) FOR THE ESTABLISHMENT OF COMPOSTING FACILITY FOR BIODEGRADABLE WASTES UNDER THE NATIONAL ORGANIC AGRICULTURE PROGRAM

WHEREAS, pursuant to Republic Act No. 10068, otherwise known as "Organic Agriculture Act of 2010" the BSWM will implement the establishment of Composting Facility for Biodegradable Wastes (CFBW) under the National Organic Agriculture Program (NOAP);

WHEREAS, BSWM and the Department of Agriculture – Regional Field Office Region III, supports Republic Act 9003, otherwise known as "Ecological Solid Wastes Management Act" which emphasized the use of environmentally sound methods that maximize the utilization of valuable resources and encourage resource conservation and recovery;

WHEREAS, R.A. 9003 states that one of the components of the LGU's Solid Waste Management Plan is the processing of waste wherein it shall define the methods and the facilities required to process the solid waste, including the use of intermediate treatment facilities for composting, recycling, conversion and other waste processing system;

WHEREAS, pursuant to such, the BSWM, DA-RFO and LGU of Pura agree to cooperate, collaborate and jointly implement the establishment of the CFBW;

WHEREAS, to define the terms of the said cooperation, there is a need to enter into an Agreement;

WHEREAS, a draft Memorandum of Agreement, in connection with the said joint-undertaking, was referred to the Sangguniang Bayan for its approval;

WHEREAS, after due hearing, spearheaded by the Committee on Rules, Privileges and Legal Matters, the Sanggunian finds the provision of the MOA to be proper;

NOW THEREFORE, on motion by Councilor John Paul M. Balmores, duly seconded, it is hereby resolved to authorize the Local Chief Executive of Pura to enter, in behalf of the municipality, into an Agreement with the Bureau of Soils and Water Management (BSWM) for the establishment of composting facility for biodegradable wastes under the National Organic Agriculture Program.

RESOLVED further, to furnish copies of this resolution to all agencies concerned.
