**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO AN AGREEMENT WITH ADVANCE INSTITUTE OF TECHNOLOGY (A.I.T.) FOR THE OFFERING OF DRESSMAKING NC II UNDER THE PROJECT HOPE SCHOLARSHIP PROGRAM**

WHEREAS, A.I.T is an educational institution offering Dressmaking NCII AND HAS INSTITUTED Mobile Training Program in cooperation with the Technical Education and Skills Development Authority (TESDA) under the Project Hope Program;

WHEREAS, the aforementioned training program offers dressmaking training to qualified residents of various LGUs;

WHEREAS, Municipality of Pura was chosen to be one of the LGU beneficiaries of the aforementioned program;

WHEREAS, to define the terms and conditions of the agreement, a draft Memorandum of Agreement was referred to the Sangguniang Bayan for review;

WHEREAS, finding the provision of the agreement to be reasonable, the Sangguniang Bayan approved the same and resolves to authorize the Municipal Mayor to enter into said agreement in behalf of the municipality;

NOW THEREFORE, on motion by Councilor John Paul M. Balmores, duly seconded, it is hereby RESOLVED to authorize Hon. Mayor Concepcion Zarate MD, to enter, in behalf of the municipality, into an agreement with Advance Institute of Technology (A.I.T.) for the offering of Dressmaking NC II under the Project Hope Scholarship Program.
