**A RESOLUTION ENDORSING TO THE LTFRB THE PETITION OF RAMOS PURA GERONA AND TARLAC CITY (RAPUGETA) TRANSPORT ASSOCIATION INC. FOR THE ESTABLISHMENT OF UV EXPRESS ROUTE THAT WILL SERVE COMMUTERS FROM THE MUNICIPALITIES OF RAMOS, PURA, GERONA AND TARLAC CITY**

WHEREAS, RAPUGETA Transport Inc., a newly organized transport group duly registered with the Securities and Exchange Commission with office address at Barangay Coral, Ramos, Tarlac, signified its desire to establish a transport route that will service commuters from the Municipalities of Ramos, Pura, Gerona and Tarlac City;

WHEREAS, among the steps taken by the organization is to seek approval and acceptance from residents and officials of affected municipalities;

WHEREAS, the said approval or acceptance in the form of a Sangguniang Bayan Resolution will be utilized by the organization in its petition to establish a transport route in the above-mentioned municipalities;

WHEREAS, after consultation and evaluation, the Sanggunian finds the request of RAPUGETA Transport Inc. to be of merit;

NOW THEREFORE, upon motion of Councilor Nenita M. Cabarios duly seconded, be it:

RESOLVED, as it is hereby resolved, to endorse to the LTFRB the petition of Ramos Pura Gerona and Tarlac City (RAPUGETA) Transport Inc., for the establishment of a UV Express Route that will serve commuters in the Municipalities of Ramos, Pura, Gerona and Tarlac City;
