**RESOLUTION NO. 097**

Series of 2016

**A RESOLUTON AUTHORIZING THE MUNICIPAL MAYOR TO SUBSCRIBE TO THE LAND BANK OF THE PHILIPPINES INTERNET BANKING FACILITY KNOWN AS “weAccess”; AND FURTHER DESIGNATING THE MUNICIPAL MAYOR AND THE MUNICIPAL TREASURER OF PURA, TARLAC AS “AUTHORIZERS”; AND THE MUNICIPAL ACCOUNTANT OF PURA AS “MAKER” IN THE *weAccess* PAG-IBIG BILLS PAYMENT FACILITY**

WHEREAS, Republic Act No. 8792, otherwise known as the *E-commerce Act of 2000*, and its implementing rules, states that, all government owned and controlled corporations are mandated to provide a method and manner of payment or settlement of fees and other obligations to the government through systems using electronic data messages or electronic documents;

WHEREAS, PAG-IBIG Fund, pursuant to Board Resolution No. 3114 dated May 26, 2015, has adopted and implemented an electronic collection platform in partnership with its various accredited banks;

WHEREAS, Circular No. 355 dated July 1, 2015 mandated remittance of contributions and loan payments by employers via electronic payment and collection facilities starting July 31, 2016;

WHEREAS, Land Bank of the Philippines Memorandum dated March 23, 2016 provided step-by-step procedure as reference in orienting and guiding corporate clients in using weAccess PAG-IBIG Bills Payment Facility;

NOW THEREFORE, pursuant to the aforementioned Memorandum by the Land Bank of the Philippines, on motion by Councilor John Paul M. Balmores, duly seconded, be it:

RESOLVED, as it hereby resolved, by the Sangguniang Bayan of Pura, on regular session assembled, to authorize the Municipal Mayor to subscribe to the Land Bank of the Philippines internet banking facility known as “weAccess”; and further designates the Municipal Mayor and the Municipal Treasurer of Pura, Tarlac as “Authorizers”; and the Municipal Accountant of Pura as “Maker” in the weAccess **PAG-IBIG Bills Payment Facility**;

RESOLVED FURTHER, to furnish copies of this resolution to the Office of the Municipal Mayor, Municipal Treasurer, Municipal Accountant, Land Bank of the Philippines and to other agencies concerned for their information and guidance.
