**A RESOLUTION AUTHORIZING THE REALIGNMENT OF THE AMOUNT OF FOUR
HUNDRED NINETY THOUSAND PESOS (P490,000.00) FROM AVAILABLE SAVINGS TO
AUGMENT THE DEPLETED FUNDS UNDER THE OFFICE OF THE MUNICIPAL MAYOR,
OFFICE OF THE MUNICIPAL ASSESSOR, SUPPORT FUND TO ANTI-DANGEROUS DRUGS
ACT OF 2012 AND SUPPORT FUND TO ESWM/MRF OPERATION**

WHEREAS, there is a need to augment the depleted MOOE of the Office of the Municipal Assessor, MOOE of the Office of the Municipal Mayor, Support Fund to Anti-Dangerous Drugs Act of 2012 and Support Fund to ESWM/MRF Operation;

WHEREAS, there are available savings in the amount of **Four Hundred Fifty Thousand Pesos (P450,000.00)** under the Miscellaneous and Other Operating Expenses (MOOE) of the Office of the Municipal Assessor and **Forty Thousand Pesos (P40,00.00)** under the Economic Development Fund of 2016;

WHEREAS, the Local Government Code of 1991 provides that a Supplemental Budget may be enacted by way of budgetary realignment to set aside appropriations for the payment of services which are exceptionally urgent and the sources of funds available for appropriations are clearly indicated and certified under oath by the local treasurer and local accountant attested by the Local Chief Executive;

NOW THEREFORE, on motion of Coun. Timoteo D. Balmores, duly seconded, be it:

RESOLVED as it is hereby RESOLVED, to authorize the realignment of the amount of **Four Hundred Ninety Thousand Pesos (P490,000.00)** from available savings under the Miscellaneous and Other Operating Expenses (MOOE) of the Office of the Municipal Assessor and under the Economic Development Fund of 2016 to augment the depleted funds under the Office of the Municipal Mayor,
