**A RESOLUTION APPROVING/ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT
PLAN OF THE MUNICIPALITY OF PURA FOR THE FISCAL YEAR 2016**

WHEREAS, Article 410 of the Implementing Guidelines of RA 7160 provides that the Local Development Council shall submit to the Local Finance Committee a copy of the Local Development Plan and Annual Investment Plan prepared and approved during the fiscal year in accordance with applicable laws, specifying therein the projects proposed for inclusion in the local government budget;

WHEREAS, on November 15, 2015, the Sanggunian Bayan of Pura, approved the Annual Investment Plan (AIP) of the municipality for the CY 2016;

WHEREAS, the Municipality of Pura was among the Local Government Units that were awarded the "2016 Seal of Good Local Governance", which was a result of an assessment conducted by the DILG on CY 2015;

WHEREAS, under DILG Memorandum Circular No. 2016-153, recipients of the above-mentioned award are eligible to access the 2016 PCF incentive in the amount of Three Million Pesos (P 3,000,000.00) (Municipalities);

WHEREAS, to concur with the requirements/guidelines on the utilization of the PCF incentive, the Local Development Council (LDC) convened to discuss the possibility of making adjustments to the 2016 AIP of Pura;

WHEREAS, the LDC presented to the Sangguniang Bayan the Supplemental AIP approved by the said council in the meeting mentioned in the next preceding paragraph;
