**RESOLUTION NO. 110**

**A RESOLUTION REALIGNING THE AMOUNT OF TWO MILLION NINETY NINE  
THOUSAND FOUR HUNDRED FIFTY THREE PESOS AND FIFTY EIGHT CENTAVOS  
(P2,099,453.58) INTENDED FOR TERMINAL LEAVE BENEFITS FOR THE GRANT OF YEAR  
END BONUS AND PRODUCTIVITY ENHANCEMENT INCENTIVE (PEI) TO QUALIFIED  
GOVERNMENT PERSONNEL FOR FY 2016**

WHEREAS, Section 6 of Executive Order No. 201 Series of 2016 provides that “Beginning FY 2016, the Productivity Enhancement Incentive shall be given not earlier than December 15 of every year to all qualified government employees at Five Thousand Pesos (P5,000.00) each for the purpose of improving the government employees’ productivity”;

WHEREAS, the DBM issued Budget Circular No. 2016-4 prescribing the rules and regulations on the grant of the Year End Bonus and Cash Gift to qualified government personnel for FY 2016;

WHEREAS, to be able to grant Productivity Enhancement Incentive (PEI) and Year-End Benefit to qualified personnel of this LGU, there is a necessity to realign funds from available sources;

WHEREAS, the Statement of Supplemental Appropriation submitted by the Municipal Budget Officer indicates that the amount of **Two Million Ninety Nine Thousand Four Hundred Fifty Three Pesos and Fifty Eight Centavos (P2,099,453.58)** intended for Terminal Leave Benefits is now available for realignment;

NOW THEREFORE, on motion of Councilor Timoteo D. Balmores, duly seconded, be it:

RESOLVED as it is hereby Resolved, to realign the amount of **Two Million Ninety Nine Thousand Four Hundred Fifty Three Pesos and Fifty Eight Centavos (P2,099,453.58)** intended for Terminal Leave Benefits for the grant of Year End Bonus and Productivity Enhancement Incentive (PEI) to qualified municipal government personnel for FY 2016;
