RESOLUTION NO. 156

Series 2016

A RESOLUTION REALIGNING THE AMOUNT OF SIX HUNDRED TEN THOUSAND PESOS (P610,000.00) FROM SAVINGS UNDER THE PERSONAL SERVICES OF THE DIFFERENT OFFICES OF THE LGU FOR THE GRANT OF MONETIZATION OF LEAVE CREDITS TO QUALIFIED MUNICIPAL OFFICIALS AND EMPLOYEES

WHEREAS, pursuant to the CIVIL SERVICE COMMISSION and the DEPARTMENT OF BUDGET AND MANAGEMENT Joint Circular No. 2-97, officials and employees in the career and non-career service, whether permanent, provisional, temporary or casual, shall be allowed to monetize a maximum of thirty (30) days vacation leave/service credits, subject to the following conditions:

1. There shall remain five (5) days vacation leave/service credits after monetization; and
2. Said official or employee has accumulated no less than fifteen (15) days vacation leave/service credits, in which case he can monetize no more than ten (10)days.

WHEREAS, all the qualified Municipal Officials and employees signified their intention to monetize ten (10) days of their accumulated leave credits to augment their income during the Christmas season;

WHEREAS, to be able to grant the monetization of leave credits to qualified municipal officials and employees, there is a necessity to realign funds from available savings under the Personal Services of the different offices of the Local Government Unit;

WHEREAS, according to the Statement of Supplemental Appropriation submitted by the Municipal Budget Officer, there is a sufficient amount available for realignment;

NOW THEREFORE, on unanimous motion presented, be it:

RESOLVED as it is hereby resolved, to realign the amount of **Six Hundred Ten Thousand Pesos (P 610,000.00)** from savings under the Personal Services of the different offices of the LGU for the grant of monetization of leave credits to qualified municipal officials and employees.

RESOLVED FURTHER, to furnish copy of this resolution to all agencies concerned for their information and guidance.
