**A RESOLUTION AUTHORIZING THE PURCHASE OF TWO (2) DRR RESCUE VEHICLES USING THE LGSF-AM FUND**

WHEREAS, the Local Government Unit of Pura has passed and complied with the “*Governance Conditions*”: i) Good Financial Housekeeping (GHF) of the Department of Interior and Local Government (DILG), ii) Public Financial Management (PFM) of the Department of Budget and Management (DBM) and iii) Local Development Council (LDC) Functionality Assessment;

WHEREAS, as a result of the said assessment, the municipality was awarded the amount of Php 9,676,232.00 directly released by DBM through the Bureau of Treasury to the LGU Account for the implementation of the projects proposed by the LGU;

WHEREAS, among the projects proposed by the Local Disaster Risk Reduction Management (LDRRM) Council is the purchase of additional two (2) rescue vehicles amounting to Two Million Pesos (Php 2,000,000.00);

WHEREAS, after a favorable recommendation by the Committee on Finance, Budget and Appropriation, the Sanggunian deems it necessary and proper to authorize the purchase of two (2) motor vehicles;

NOW THEREFORE, on motion of Councilor Timoteo D. Balmores, duly seconded, it is hereby

RESOLVED to AUTHORIZE/APPROVE the purchase of Two (2) DRR Rescue Vehicles using the Local Government Support Fund – Aid to Municipalities (LGSF-AM);
