A RESOLUTION AUTHORIZING THE REALIGNMENT OF FOUR HUNDRED NINETY SIX THOUSAND ONE HUNDRED SIXTY FIVE PESOS AND 52/100 (P 496,165.52) FROM SAVINGS IN THE PERSONAL SERVICES TO ALLOCATE FUND FOR CREATED ADDITIONAL POSITIONS OF THIS MUNICIPALITY AND ADDITIONAL CLOTHING ALLOWANCE OF QUALIFIED MUNICIPAL EMPLOYEES

WHEREAS, there is a need to allocate funds for the Newly Created Positions of this Municipality and to augment funds for the Additional Clothing Allowance of qualified municipal employees;

WHEREAS, funds are available for realignment from savings in the Personal Services under the Office of the Municipal Agriculturist (P 296,286.64) and Municipal Treasurer (P 248,879.28);

WHEREAS, the Local Government Code of 1991 provides that a Supplemental Budget may be enacted by way of budgetary realignment to set aside appropriations for the payment of services which are exceptionally urgent and the sources of funds available for appropriations are clearly indicated and certified under oath by the local treasurer and local accountant and attested by the Local Chief Executive.

NOW THEREFORE, on unanimous motion of Councilor Timoteo D. Balmores duly seconded, be it:

RESOLVED, as it is hereby resolved, to authorize the realignment of **FOUR HUNDRED NINETY SIX THOUSAND ONE HUNDRED SIXTY FIVE PESOS AND 52/100 (P 496,165.52)** from savings in the personal services to allocate fund for created additional positions of this municipality and additional clothing allowance of qualified municipal employees;
